## **RMA Post-Secondary Scholarship Program**

The 2018 application term is now open and closes August 31, 2018

In recognition of the importance of an educated population to the future well-being of rural communities, the Rural Municipalities of Alberta (RMA) established the RMA Scholarship Program in 1995. The RMA Scholarship Program is designed to encourage young rural Albertans to pursue further education, and thereby enhance the ability of these young people to make meaningful contributions to their communities in subsequent years. A scholarship in the amount of \$1,000 is presented to one successful applicant from each of the five districts.

#### **Eligibility and Application Procedure**

To be eligible, an applicant must:

- Be a resident of a municipality which is a member in good standing of RMA, including municipal districts, counties, specialized municipalities and the Special Areas;
- Be registered in his or her first four years of study at a recognized post-secondary institution (i.e. the applicant must not have any previous degrees or diplomas); and
  - Preference will be given to candidates attending a recognized post-secondary institution in Alberta, except in instances where the chosen program of study is not available in Alberta.
- Be pursuing a course of studies of relevance to local government and/or rural communities.
  - This criterion is not intended to restrict eligibility; instead, applicants are invited to explain the relevance of their intended study program within their letter of application.

The submission packages must include the following items:

- Complete RMA Post-Secondary Scholarship Application form; click here for the application.
- A letter from municipality Chief Administrative Office (CAO) providing proof of residency
- A letter from the applicant, setting out his/her goals and objectives in pursuing further education, as well as the relevance of their study program to local government and/or rural communities;
- Official transcripts of his/her high school marks (photocopies are acceptable provided that the
  photocopy includes the signature of a school or municipal official, along with that official's
  confirmation that the photocopy is a true copy of the original);
- A brief resume outlining employment experience, community involvement, volunteer activities, recreational activities, cultural pursuits, etc.; and

Rural non-residential small businesses can now apply to receive new tax savings. Qualifying rural non-residential small businesses can receive a 25 per cent reduction from the rural non-residential tax rate. To qualify, properties must meet criteria outlined in provincial regulation, specifically:

- Currently taxed as rural non-residential;
- Property must be owned or leased by a business (properties subleased are excluded);
- Business must hold an RMWB Business Licence as of December 31, 2017\*;
- Business must have fewer than 50 employees across Canada; and
- Business must not be a designated industrial property as identified by the Provincial Assessor.

#### **GRIEF: A Misunderstood and Neglected Emotion**

Grief is one of the most misunderstood emotions, the assumption being that it is only connected with death. Grief is:

- A normal and natural reaction to a significant emotional loss of any kind.
- · Conflicted feelings caused by the end of or a change in familiar patterns of behaviour.
- The feeling of reaching out for someone who has always been there only to find when you need them again, they are no longer there.
- Not a pathological condition.

#### Short Term Energy Relieving Behaviors (STERBS)

STERBS are either behaviours or activities that grievers engage in as a way of avoiding feelings associated with grief. We are socialized with the idea that we should cover up emotional pain rather than confront it directly. Sometimes behaviours or activities used as STERBS are things we will not want to share with others. Three major problems with STERBS are:

- They appear to work in the short-term
- · They create an illusion of recovery by causing us to forget or bury emotions
- The situation remains the same.

# CALL FOR ARTWORK


